[REDACTED] has noted with pleasure the agreement of U.S.C.I.B. to hold discussions with [REDACTED] representatives on the subjects mentioned in paras 1 and 2 of CIB 00045 dated 18th April, and agrees to the proposed order of taking the [REDACTED] and [REDACTED] problems.

2. [REDACTED] is happy to accept the invitation to hold such discussions in Washington. In spite of the urgency and importance of the matter, which, it is understood, has been stressed by the [REDACTED] Chiefs of Staff in a communication forwarded via the Head of the [REDACTED] in Washington to the U.S. Joint Chiefs of Staff, [REDACTED] regrets that it is impossible to meet the date of mid-May as suggested by U.S.C.I.B.

3. [REDACTED] proposes that the discussions should start in Washington on 5th June and, in anticipation of this being acceptable to U.S.C.I.B., has booked air passages to Washington for the [REDACTED] delegation on Wednesday 3rd June.

4. The [REDACTED] delegation will consist of [REDACTED], re-inforced as necessary in Washington from the staff of the [REDACTED] and of the [REDACTED] [REDACTED] will be representing the Cypher Policy Board.

5. It is the hope of [REDACTED] that it will be possible for the discussions to be concluded by Friday 12th June. The co-operation of your Board towards the realisation of this hope would be appreciated.

6. It is intended to make a [REDACTED] paper available to the U.S. authorities in Washington by 27th May and it is hoped that U.S.C.I.B. will find it possible to have a paper available in London on or before that date.
