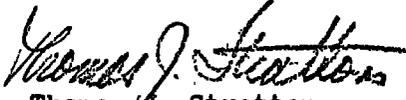
2. The fifth meeting will be held on Wednesday, 15 September 1954, at 0900, in Room 19-232B, Naval Security Station.
