1. For reasons heretofore explained, it is desired to suspend official action in connection with the above entitled application for the purpose of deferring the allowance and issuance of a patent. In other words, publication of the subject matter by the grant of a patent is to be postponed for an indeterminate period.

2.. In cases of this character where deferment of the issuance of a patent is desired, it becomes necessary to invoke what is known as the three year rule. A full compliance with this rule requires a formal transfer of title in favor of the Government, that is to say, a full assignment and transfer of ownership. As this case now stands, the record title or ownership is vested in the applicants, subject to an irrevocable non-exclusive license in favor of the Government. In order to obviate the execution at this time of an outright assignment, which would divest Messrs. Friedman and Graham of their ownership in this invention, application and patent to be granted thereon, the present procedure of requesting a suspension of action has been adopted.
