USCIB: 13/297 Item 2 of the Agenda for the Eightieth Meeting of USCIB, held on 28 November 1952.

Subject:

Measures for Increased Security of COMINT (Ad Hoc Committee Report on Proposed Revision of Appendix B. BRUSA)(USCIB 13/294).

The Acting CHAIMAN (General Camine) recalled previous Board approval of the draft revision of Appendix B, which had been sent to LSIB for consideration, and stated that the ad hoc committee now recommended approval of two papers in further clarification of that document. One, he said, was designated "KHHEIT I" to the proposed revision, which defined more specifically the several categories of COMINT; the other paper recommended revision of two paragraphs of the revision previously approved. He informed the members that it had been suggested that the latter recommendation be amended by the insertion of the word "complex" before the words "changing callsign" in paragraphs lA and lB, thereby bringing the recommendation into agreement with British proposals on the subject. He proposed that, with this amendment, the ad hoc committee recommendations contained in USCIB 13/294 be approved, and the Secretary be instructed to prepare the proposals for forwarding to LSIB for consideration.

The members approved the ad hoc committee recommendations, subject to the amendment suggested by the Acting Chairman.

MR. ARMSTRONG suggested that the ad hos committee be commended for the efficient manner in which they completed a very difficult job in such a short period of time.

The members agreed.

The Acting CHAIRMAN asked the Chairman of the ad hos committee, Mr. Polysoides, to express the appreciation and commendation of the Board to the members of his committee.

DECISION: (28 November 1952) USCIB (1) approved the report of the ad hos committee as contained in USCIB 13/294, subject to the insertion of the word "complex" before the words "changing callsign" in paragraphs 1A and 1B of Enclosure A therewith; and (2) instructed the Secretary to prepare the proposals for forwarding to LSIB for consideration, and (3) dissolved the ad hoc committee, after requesting that the Chairman convey to the members the appreciation and commendation of the Board.

Subject:

USAF Category III Requirements (USCIB 13/287).

The Acting CHAIRMAN (General Canine) stated that in connection with this problem, it should be assumed that Revised Appendix B has already been forwarded to LSIB. He said that he wished to report, as Coordinator, that plans for the U.K. party of five members to visit Korea to observe the conduct of COMINT operations under combat conditions were being formulated, and that Australian participation in this visit had been clarified. He added that the concurrence of CINCPE in the visit had been requested but that no reply had yet been received.

GENERAL SAFFORD stated, in connection with the position of the British on the question of ferret aircraft, that the Air Force had notified the Commander, FRAF of the illegality of the procedure now being used, and directed its discontinuance for the time being. He added that the Air Force hoped that the visit to Korca would clarify British views, permitting reconsideration of the matter at a later date.

The Acting CHAIRMAN asked if there was any objection to notifying the British that we accept their proposed rewording of paragraph 33, Appendix B, as an interim measure pending U.S./U.K. agreement on the proposed revision of Appendix B in its entirety.

There were no objections.

DECISION: (28 November 1952) USCIB approved the proposed rewording of paragraph 33, Appendix B, BRUSA, as set forth in USCIB 13/287 and agreed that U.K. authorities would be so informed.

This item to be dropped from the agenda.

ADJOURNMENT OF SOLD MEETING

The Asting CHAIRMAN (General Camine) stated that the foregoing was the last item of business to be considered by USCIB, as constituted prior to the recent revision of NSCID No. 9.

It was moved and seconded that the 80th Meeting be adjourned.
